Required Documents:

• Passport or identity card of the parents	• Citizenship certificates of the parents
• Birth certificates of the parents	• Registration confirmations of the parents
• Marriage certificate of the parents	• If applicable, proof of academic degrees of the parents
Completely filled out registration form for the child Instructions for completing the registration form for the newborn: In the two columns at the bottom (accommodation provider), the mother should enter her details and sign the registration form in both columns, stating the current date. Left column: Mother's name in capital letters, date, mother's signature Right column: Mother's signature, date	

Legitimate Children: The registration can be applied for electronically and you will receive the documents by post. However, it is important that we receive all your documents by scan. In case of any uncertainties, we reserve the right to prefer a personal registration at the Registry Office.

Please send all documents (as a PDF file) together with the application form (pages 1 and 2) and the completed registration form for the newborn to the Linz Registry Office: **standesamt@mag.linz.at**.

If you have a mobile signature or citizen card and were married in Austria after 01.11.2014, you have the option to complete the registration via the Digital Babypoint.

Illegitimate Children: Please understand that currently name determinations, paternity acknowledgements and custody agreements **can only be carried out after telephone appointment** under: 0732/7070.

Please note that the legal provisions for receiving some family benefits (such as childcare allowance and family time bonus) provide for **a very short deadline** for registering the child's main residence (registration takes place during the re-registration of the birth at the Registry Office). For organisational reasons, it is therefore **absolutely necessary** that the application for re-registration of the birth at the Registry Office is made **as soon as possible after the birth** of your child, as timely processing cannot otherwise be guaranteed (**for questions in this regard, please contact your health insurance directly!**).
